Privacy policy | Information for website visitors

Pursuant to art. 13 of the UE Regulation 2016/679

Interested persons: visitors of the website <http://www.millemigliashop.com>

The aim of this document is to describe the handling modes of this website, with reference to processing of personal data of the users/visitors who visit it according to the Regulation 2016/679/UE concerning personal data protection (hereinafter called "the Regulation").

This document is also to be meant as information given to people who interact with the services offered by this website, according to art. 13 of the Regulation.

Personal Data collection and processing

Navigation Data

The information systems and software procedures that enable the operation of this website acquire personal data as part of their standard functioning; the transmission of such data is an inherent feature of Internet communication protocols. Such information is not collected in order to be associated to identified data subjects, however, due to its very nature, it could allow for identification of the users by processing and associating with data held by third parties. This category of data includes IP addresses or domain names of the computers used by any user connecting with the site, the URI addresses (Uniform Resource Identifier) of the requested resources, the time of such request, the method used for submitting a given request to the server, the size of the response file, the numerical code relating to server response status (successfully performed, error, etc.) and other parameters related to the user's operating system and computer environment.

This data is used for the sole purpose of obtaining statistical information about the use of the site as well as checking its functioning.

The data could be used to establish liability in the case any cybercrimes are committed to the detriment of the site.

Provision of data

Purpose of data processing and scope of personal data communication

Processing modes

Data dissemination

The data we process may also be communicated to Subjects that are contractually linked to the Controller within the European Union.

Data will be communicated to third parties included in the following categories:

- Managers of platforms that provide Social Network or Analysis services;
- Companies providing hosting services concerning the website data base; the servers are located in Italy at a server farm certified in compliance to ISO 9001:2015 and ISO 27001:2013 standards;
- Companies managing the website data base on an outsourcing basis;
- Consultants and Professionals even in association;
- External collaborators with technical and marketing tasks;
- Security Authorities.

The subjects included in the abovementioned categories are entrusted with the task of Data Processor pursuant to Art. 28 of GDPR, or Joint Controller pursuant to Art. 26 del GDPR or they may act in complete autonomy as separate Data Controller. The list of said subjects is kept continuously updated and is available at our headquarters.

Your data will not be disclosed in any manner whatsoever.

Data transfer to extra UE countries

Your personal data will be stored within the European Union, but also at companies that provide hosting or analysis services and that have their headquarters in Italy and in Europe.
